TENDER NOTICE NO. 01/NNF/2ND CALL/ 2014-15

Tender for Poly Propylene rope for Nylon Net Fencing in 24 Parganas (South) Division

- 1) Sealed tenders are invited from bonafide / authorised dealer having proper PAN & VAT certificate along with trade clearance for supply of Poly Propylene rope having 3 stand IR 4mm, PPARA yellow colour in 24 Parganas (South) to mitigate Human-Tiger Conflict.
- 2) Tender Papers for the above mentioned work will be available from Attached Forest Ranger in the office of the Divisional Forest Officer, 24 Parganas (South) Division at 12, Biplabi Kanailal Sarani, New Administrative Building, 4th Floor, Alipore Kolkata - 700027 on all working days from 19.06.2014 to 26.06.2014 from 11.30 AM to 4:00 PM. at the cost of Rs. 500/- by cash.
- 3) Last date for submission of tender is 27.06.2014 at 2.00 p.m. and the same will be opened at 3.00 p.m. on same day in presence of tenderer or his authorized representatives.
- 4) The tender shall be submitted in sealed envelop with **"Tender for Poly Propylene rope for use in 24 Parganas (South)"** written on the envelop and the same should be addressed by name to "Lipika Ray, IFS, Divisional Forest Officer, 24 Parganas (South) Division, 12, Biplabi Kanailal Bhattacharjee Sarani, New Administrative Building, 4th Floor, Alipore, Kolkata - 700027 Kolkata and not by her designation. The sealed tender should be submitted through registered post or in person between 11.30 a.m to 4.00 p.m. on any all working day from 19.06.2014 to 26.06.2014.

Tender Conditions against Tender Notice No. 01/NNF/2ND CALL/ 2014-15

- 1) Supplier must be a bonafide entity or an Authorized Dealer.
- 2) Supplier must have proper trade licence & PAN & VAT Clearance Still 31.03.2014.
- 3) The Poly Propylene rope to be supplied should have exact specification of 3 Stand IR 4mm, PPARA yellow colour and price is to be per kg.
- 4) Supply should be made upto Raidighi Range Office / Matla Range Officer at Canning / Ramganga Range Office including carriage and rates to be quoted accordingly. Rates should be exclusive of VAT and VAT should be mentioned separately in the tender.
- 5) Supply should be made as & when necessary within 30(thirty) days of issuance of letter of acceptance and work Order.
- 6) The Divisional Forest Officer, 24 - Parganas (South) Division the right to reject any or all the Tenders or any condition of the Tender Notice without assigning any reason.
- 7) The Divisional Forest Officer, 24 Parganas (South) Division is not bound to accept the lowest rate.
- 8) All intending Tenderers shall have to deposit an Earnest Money Deposit of Rs. 1000/- (Rupees one thousand) only in the form of Demand Draft / Call deposit from a Nationalized Bank drawn in favour of the Divisional Forest Officer, 24-Parganas(South) Division along with tender papers in a separate envelope failing which Tenders will not be considered for competition. The EMD will be released to the unsuccessful tenderers on written application after 15 days from successful completion of all formalities of the tender.
- 9) EMD of the successful tenderer **cannot be adjusted** against the security deposit. If the successful Tenderer fails to execute the required Agreement within the stipulated period, the EMD will be forfeited to the Govt.
- 10) The successful tenderer will have to deposit a "Security Deposit" money of Rs. 8000/- (Rupees eight thousand) only in the form of bank draft / call deposit from a nationalized bank in compliance with Finance Department, WB's memo no 5020-FY dated 15.06.2012 and deposit directly to Treasury link bank (State Bank of India, Alipore Court Treasury Branch) and submit to this office two copies of receipted challan. Tenderer should sign

an "Agreement" with this office within 07 (seven) days from the date of communication and acceptance of the Tender.

- 11) The SD money will be released by Treasury (Alipore -II) only after expiry of the contract. On completion of the contract, the tenderer shall obtain a release order from the undersigned and submit the same with completion report to the Treasury Officer, Alipore - II. On receipt of the same, the security deposit will be released by the Treasury.
- 12) In case of breach of conditions of any part of contract of agreement the SD or part thereof will be liable to forfeiture.
- 13) Bills should be submitted by the successful tenderer in triplicate with receipt copy of Challan on completion of supply and payment will be made on the basis of release of govt. sanction.
- 14) The tender will remain valid till 31.03.2015.
